I understand and accept the above risks of bodily injury related to this activity.
2. ☐ **RELEASE OF LIABILITY:** In consideration of being permitted to participate in activities offered at X-Treme Challenge, you for yourself as a Participant or as parent or legal guardian of a minor Participant and also on behalf of your spouse, legal representatives, heirs and assigns hereby release, waive, discharge and indemnify X-Treme Fun Athletic, Inc. and X-Treme Challenge Arena and its officers, directors, employees, volunteers, landlords, and agents and/or anyone else directly or indirectly connected with the company, from any and all loss, liability, damage or cost resulting from injury to the Participant's person or his or her property, whether caused by the negligence of X-Treme Challenge or its employees or otherwise, while Participant is engaged in any of the activities offered by X-Treme Challenge Arena.
